# **Consent with Provision of Personal Data**

#### 1. Personal Data Administrator

The administrators of the personal data are as follows: **VSB – Technical University of Ostrava**, 17. listopadu 2172/15, 708 00 Ostrava - Poruba, CRN: 61989100 (hereinafter only "Administrator").

Please be informed that in accordance with the act on protection of personal data and the general by-law on the protection of personal data you are also entitled to the following actions:

- To require information from us on the way we process your personal data, or a document confirming that your personal data has been deleted; the Administrator is entitled to receive reimbursement no higher than the costs necessary to give the information.
- To require explanation from us concerning the processing of your personal data.
- To ask us to provide you access to this data and have it updated or corrected.
- To take back your consent to process the data and ask as to delete it, providing there is no legal reason to process it.
- In case of doubts about our performing the duties associated with processing of personal data to approach either us or the Office for Personal Data Protection.
